Lts 1-9 and 12-17 excluding 10 & 11. Additionally include Lts 1-2 Rasmussen Addition E1/2, NW1/4, NE1/2, Section 23, Township 93 North, Range 57 West of the 5th PM. All present voted aye; motion carried.

No Action was taken on the Tax Freeze Abatement request.

Action 17121C: A motion was made by Epp and seconded by Woods to approve the consent agenda. All present voted aye; motion carried.

The Yankton County Welfare Report for March 2017 included 9 contacts and 11 notices of hospitalization and 3 medical bills for the County Jail.

ROD: The Register of Deeds report from March 2017 showed collection of \$12,230.00 in regular fees; \$17,729.50 in transfer fees; and \$1,661.50 in copies revenue.

Veterans Office: VSO Michael McDonald's March 2017 report showed 151 contacts on behalf of veterans last month. McDonald also coordinated transportation of 19 veterans (nine trips) to appointments at the VA Hospital in Sioux Falls.

EMS: Emergency Medical Services monthly report for March 2017 listed 181 total calls. Year to date Yankton County EMS has collected \$182,409 and spent \$225,920.

Auditor/Treasurer: The Auditor's Monthly Settlement with the Treasurer as of March, 2017 showed Total Cash of \$7,943,169.65. The General Fund was \$4,631,295.82; Special Funds were \$1,492,135.90; and Trust and Agency Funds were \$1,819,737.93 adding to a Grand Total of General Ledger Cash and Investments of \$7,943,169.65. A detailed report is on file with the County Auditor.

MI Income: The MI Illness income for March 2017 was \$6,903.80.

Sheriff: Sheriff's office collected \$17,176.42 in fees last month. Jail income was \$124,966.88 in December. There were 61 county inmates, 84 city inmates, 43 state inmates and 40 federal inmates. Income from the 24-7 program was \$4,635.00 in March.

Plat: Whereas it appears, Patrick Riibe owner of record, has caused a plat to be made of the following real property: Parcel B and Parcel C, Kabeiseman Tract 2, NW1/4, SE1/4 and NE1/4, SW1/4, S1-T93N-R57W, County of Yankton, S.D., and has submitted such plat to the

Yankton County Planning Commission and the Yankton County Commission for approval. Now therefore be it resolved that such plat has been executed according to law and conforms to all existing applicable zoning, subdivision and erosion and sediment control and the same is hereby approved. The County Auditor is hereby authorized and directed to endorse on such the proper resolution and certify the same.

Action 17122D: A motion was made by Woods and seconded by Bodenstedt to recess the regular session and convene as Drainage Board. All present voted aye; motion carried.

Action 17123D: A motion was made by Epp and seconded by Woods to approve a Drainage Permit request from applicant Karl Schenk, based on Findings of Fact Dated March 28, 2017. Said property is described as E1/2, SW1/4 & SE1/4, S26-T94N-R55W, hereinafter referred to as Mission Hill North Township, County of Yankton, State of South Dakota. All present voted aye; motion carried.

Action 17124D: A motion was made by Epp and seconded by Bodenstedt to approve a Drainage Permit request from applicant New Hope Farm Revocable Trust, based on Findings of Fact dated March 28, 2017. Said property is legally described as Tract 1, Nelsen 2nd Addition, NE1/4 exc Nelsen Addition, NE1/4, S27-T94N-R55W, hereinafter referred to as Mission Hill North Township, County of Yankton, State of South Dakota. All present voted aye; motion carried.

Action 17125C: A motion was made by Epp and seconded by Swensen to recess the Drainage Board and reconvene in regular session. All present voted aye; motion carried.

Health Nurse: Jen Wechsler, RN, provided the 2017 first quarter report from the S.D. Department of Health and Yankton County WIC Office.

Ambulance: Ambulance Administer Steve Hawkins and the Board discussed standby charges for non-profit group events or events put on by taxpayer-supported public entities (city, school district). Hawkins Also presented a letter authorizing the County EMS Administrator and billing specialist to set up, renew, work with and update YCEMS information with insurance companies on behalf of Yankton County.

Action 17126AMB: A motion was made by Bodenstedt and seconded by Woods to approve the recommendation to provide services to Non-Governmental entities and to increase the single EMS provider to \$25 per hour and Ambulance and crew to \$75.00 per hour. All present voted aye; motion carried.

Comprehensive Plan: Zoning Administrator Pat Garrity addressed the board on the progress for the county's revised comprehensive plan. Garrity stated that his goal is to have the plan on the county website by May.

Citizens of the Year: Chairman Kettering read a proclamation recognizing Larry and Diane Ness as 2016 Yankton Citizen of the Year.

County Health Insurance: Tara Stombaugh from Avera Health Plans and Julie Auch from Wellmark appeared before the board to discuss quotes for health insurance for Yankton County employees.

Action 17127C: A motion was made by Woods and seconded Bodenstedt to contract with Wellmark for the 12-month period that begins June 1, 2017, premiums being \$594.34 for single per month. All present voted; motion carried.

Reconstruction of Road: Dan Rederick and several county residents voiced concerns on the reclamation process that will be done on 301st St. in Marindahl Township. Some of the issues that were presented: the County's resolve to finish the project, trust issues with the commission, and if the reclamation would be safe. Tom Mertz from Loiseau Construction also spoke on the process of reclamation.

Action 17128C: A motion was made by Woods and seconded by Bodenstedt to recess the regular session at 7:15 pm and convene in Executive Session to discuss personnel and pending litigation. All present voted aye; motion carried.

Action 17129C: A motion was made by Bodenstedt and seconded by Epp to adjourn executive session at 8:08 pm and reconvene in regular session. All present voted aye; motion carried.

Chairman Kettering reported no action would be taken as a result of the executive session.

Action 17130C: A motion was made by Epp and seconded by Bodenstedt to adjourn. All present voted aye; motion carried.
