- b. A copy of any recorded vested drainage records and/or a copy of the U.S. Natural Resources Conservation Service or NRSC-CPA-026 with certified drainage systems and referenced wetland maps
- c. A copy of any easements for drainage that are involved in this application
- d. A list of all parties who must be provided notification of the proposed drainage project, to be determined by the applicant and the Lake County Zoning and Drainage Official pursuant to Lake County Drainage Ordinance #02-38
- e. All signed waivers for performing drainage work in Lake County

In addition to this application, the Lake County Zoning and Drainage Official may also require that the applicant provide a detailed survey by a professional engineer or surveyor.

The following information **must** be included as a supplement to this application, **if applicable**:

- a. Any application for a proposed drainage project which would empty into an existing drainage system shall include a description of the type and general location of the existing system.
- b. Any application for any drainage into a road right-of-way must include the written approval of the governing agency.
- c. Any application for a proposed drainage project which would involve any underground construction on a county road right-of-way must include a validated permit from the County for occupancy for underground construction on county road right-of-ways.
- d. Any application for a proposed drainage project which is determined to be of statewide or inter-county significance must be provided to the other affected counties by the applicant.
